A meeting held today on 09/03/2018 at 10:00 am in the Principal's Chamber under the chairmanship of Dr. Jugal Sarkia, Principal of the College. The meeting of the Grievances Redressal Cell discussed on the

application received from the Students' Union of N.B. College and Students' Unit of Science Stream very seriously. On the other hand Sri Jintomoni Dutta, Student of 6th Semester, (Major in Education) exercising his power excessively published some misleading information in Social Media which compels the Committee to think that this type of activity would destroy the reputation of the College as a whole.

The Cell finds that the Student/President of N.B.C.S.U. Sri Jintomoni Dutta is publishing the wrong information without knowing the right facts. The Cell accused Sri Jintomoni Dutta for the following grounds/crimes.

1. Being the President of N.B.C.S.U., Sri Jintomoni Dutta has not discussed anything with the Students' Union of the College and exercises his excessiveness using the N.B.C.S.U. Pad. The N.B.C.S.U. feels it a big crime and he should get rigorous punishment like restrictate from the college or other.

2. Sri Jintomoni Dutta is playing as a spokesman of the N.B.C.S.U. but from the portfolio he is a President and his acts should be confined in presiding a meeting and giving suggestion.

3. Whatever the student volume he shown by him it is sum total of Arts & Science Stream. Since Science Stream is still venture/

non-provincialis, there is no question of free admission system. Being the Venture Stream, the teachers are paid from the students fee. The science education may not get at cost of ₹ 5000/- only. But the North Bank College Science Stream is still rendering science education as a social service. Sri Jintanone Salla should know the real facts. Without knowing the real one, who spalls the wrong facts should get rigorous punishment.

4. Being the student of the college and member of students union, he should know the fee structure stated in the prospectus. He should discuss with the students union/principal of the college. The fee structure is approved by the Academic Committee of the college. In spite of it he has intentionally made it to demoralised the principal and devalued the college reputation, so he should get a good punishment.

5. Whatever the statistics he has supplied to the news paper "Axomiya Prabidin" published on 17th March 2018 is completely false. The laboratory fee for Education Department has not been collected from the students of Education Department, only practical fee from the 5th semester students of Edn Deptt. and students of Edn Deptt. having practical subject, practical fee is collected. He should know the difference between practical fee and laboratory fee. The students without having knowledge

of difference between these two and publishing false information should restrict from the college.

6. As the President of NCCSU, he is not a Secretary. The portfolio of President has no fund. But during college week held on 24<sup>th</sup> Jan/2018 to 30<sup>th</sup> Jan/2018, he has snatch away the power from Cultural Secretary illegally and arranged cultural programme excessively. His expenditure vouchers should be stopped and his Presidentship should be cancelled.

7. As the fee structure for the Academic Session 2017-18 is approved by the Academic Committee held on 27<sup>th</sup> May/2017 and the statement/publicity given by Sri Jintomoni Dutta is not only devalued reputation of the college and Principal, but also dishonoured the members of Academic Committee. So the accused student Sri Jintomoni Dutta should get a remarkable punishment.

8. The fee structure/fee amount is below the Govt. approved rate, but the student Sri Jintomoni Dutta intentionally doing this to demoralise the Principal.

Hence the Grievance Redressal Cell decided the following resolutions against Shri Jintomoni Dutta.

1. The student Sri Jintomoni Dutta should be restricted from the college for 3 (Three) months, as per resolution No. 1 of the NCCSU held on 29<sup>th</sup> March/2018 and Redressal of Grievances of
